VOLUNTARY ANNOUNCEMENT INCREASE IN SHAREHOLDING BY SUBSTANTIAL SHAREHOLDER

This announcement is made by Flying Financial Service Holdings Limited (“**Company**”) on a voluntary basis.

The Company was informed by Ming Cheng Investments Limited which is beneficially and wholly owned by Mr. Zheng Weijing (“**Mr. Zheng**”), an executive Director, the chairman and the chief executive officer of the Company, that Ming Cheng Investments Limited acquired a total of 12,500,000 ordinary shares of the Company (“**Purchases**”) on the open market from 26 September 2016 to 28 September 2016.

Immediately prior to the Purchases, Ming Cheng Investments Limited held 355,239,567 ordinary shares of the Company, representing approximately 20.52% of the total issued share capital of the Company. Immediately after the Purchases, Ming Cheng Investments Limited held 367,739,567 ordinary shares of the Company, representing approximately 21.24% of the total issued share capital of the Company as at the date of this announcement.

Immediately prior to the Purchases, by virtue of Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (“**SFO**”), Mr. Zheng was interested in or deemed to be interested in 395,869,769 ordinary shares of the Company, representing approximately 22.86% of the total issued share capital of the Company. Immediately after the Purchases, by the virtue of Part XV of the SFO, Mr. Zheng has become interested in or deemed to be interested in 408,369,769 ordinary shares of the Company, representing approximately 23.59% of the total issued share capital of the Company as at the date of this announcement.
