POSITIVE PROFIT ALERT

This announcement is made by the Company pursuant to Rule 17.10 of the GEM Listing Rules and Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform the Shareholders and potential investors that based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2016, it is anticipated that the Group's consolidated profit attributable to owners of the Company for the nine months ended 30 September 2016 would increase significantly as compared to that for the nine months ended 30 September 2015.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Flying Financial Service Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules (the “**GEM Listing Rules**”) Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”).

Based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2016, the board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (“**Shareholders**”) of the Company and potential investors that, it is anticipated that the Group's consolidated profit attributable to owners of the Company for the nine months ended 30 September 2016 would increase significantly by approximately 250% as compared to the corresponding period in 2015. The rise in consolidated profit attributable to owners of the Company was primarily attributable to (i) investment income of approximately RMB110 million generated from the investments in property development projects for the nine months ended 30 September 2016 (corresponding period in 2015: approximately RMB10 million); (ii) platform service income of approximately RMB20 million generated from the financial services platforms; and (iii) increase in financial consultation service income to approximately RMB80 million (corresponding period in 2015: approximately RMB43 million).

The Company is still in the process of finalising its quarterly results for the nine months ended 30 September 2016. The information contained in this announcement is only a preliminary assessment by the management of the Company with reference to the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2016 which has neither been reviewed by the audit committee nor auditors of the Company and is subject to possible adjustments upon further review. Finalised quarterly results of the Group for the nine months ended 30 September 2016 will be disclosed in the quarterly results announcement of the Group, which is expected to be published on or around 10 November 2016. Shareholders and potential investors are advised to read such results announcement carefully.
