This announcement is made by the Company pursuant to Rule 17.10 of the GEM Listing Rules and Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform the Shareholders and potential investors that based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2015, it is anticipated to record a profit attributable to owners of the Company for the nine months ended 30 September 2015 as compared to a loss attributable to owners of the Company of approximately RMB39.2 million for the corresponding period in 2014.

**Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**

This announcement is made by Flying Financial Service Holdings Limited (the “**Company**, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules (the “**GEM Listing Rules**”) Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”).

Based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2015, the board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (“**Shareholders**”) of the Company and potential investors that, it is anticipated to record a profit attributable to owners of the Company for the nine months ended 30 September 2015 as compared to a loss attributable to owners of the Company of approximately RMB39.2 million for the corresponding period in 2014. Expected profit was primarily attributable to (i) investment income of approximately RMB15.0 million (investment loss for the corresponding period in 2014: RMB20.3 million); (ii) no provision for impairment of accounts receivables recognized (corresponding period in 2014: RMB22.1 million); and (iii) decrease in income tax expense due to utilization of tax losses.

The Company is still in the process of finalising its interim results for the nine months ended 30 September 2015. The information contained in this announcement is only a preliminary assessment by the management of the Company with reference to the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2015 which has neither been reviewed by the audit committee nor auditors of the Company and is subject to possible adjustments upon further review. Finalised interim results of the Group for the nine months ended 30 September 2015 will be disclosed in the interim results announcement of the Group, which is expected to be published on or around 13 November 2015. Shareholders and potential investors are advised to read such results announcement carefully.
